In its glorious 116 (One hundred sixteen) years, Anjuman has had in its team people from the highest political and administrative echelons like Prince Gholam Mohammed Shah, Nawab Sir Samiullah Bahadur, Mr. A. K. Fazlul Haque, Mr. Shamsul Ulema, Dr. K. N. Katju, Dr. B. C. Roy and many others like them.

The promotion of friendship and fellow being among the different communities and providing religious and secular education as well as medical and financial help to the poor and downtrodden section of the society were among the noble objects of the Anjuman. But the most important and unique service of the Anjuman was founded of the burial of unclaimed dead bodies according to the Islamic Shariah. In fact Anjuman was a pioneer in the continent of Asia.

REGULAR ACTIVITIES

The Anjuman Mufidul Islam, Calcutta has been rendering valuable services in diverse fields to the best of its capacity which constitute of the following sections.

- 1. Burial Section, 2. Education Section, 3. Relief Section, 4. Medical Section and
- 5. Tabligh Section 6. Vocational Training

The details of the activities of these sections during the year under report are mentioned below under their respective heads:

1. **BURIAL SECTION**:

The unique service of Burial of unclaimed bodies according to the Islamic Shariah is appreciated by the public at large and this section is the most important section which was started from the early days of the Anjuman. The dead bodies are received from Morgues, Hospitals, Railway Platforms, and streets of Kolkata, Howrah & suburbs & Buried at the allotted block at Gobra-1. During the year under report 298 Muslim Dead bodies were collected/received & burial performed according to the Islamic Shariah.

Besides arranging the burial of dead bodies, the Anjuman also assists the public in the removal of dead bodies from Hospitals and Nursing Homes to different destinations including their residences and or to Graveyards. For carrying out this service there is only one hearse van which remains on standby round the clock.

The infrastructure at Gobra-1 is constantly in need of repair & maintainance cost is becoming dearer. As such it is my earnest appeal to the Anjuman members to engage members of the public in way of contribution on monthly basis, towards Kafan & Dafan The Hearse van also needs to be replaced as there are frequent breakdowns which becomes a setback in the service.

Again, I would appeal to the members to make a collective effort in funding the Anjuman to procure a new Hearse Van.

3. EDUCATION SECTION:

The Education Section is the second oldest section of Anjuman which is segregated in three sections.

- 1. Schools (Primary, Secondary and Higher Secondary)
- 2. Maktabs (Dini and Tablighi)
- 3. Vocational Training like Tailoring and Handicraft.
- 4. The Anjuman is in the process of opening a fourth section in the form of a Nurses Training Centre.

(a) ANJUMAN GROUP OF SCHOOLS:

The Anjuman has established itself as an institution in imparting education in Urdu Medium and is well commended for this. There are plans to open an English Medium School by Anjuman at 16, Hati Bagan Road, Kolkata – 700 014 The Anjuman has established and is maintaining the following schools which are duly recognised by the West Bengal Government Education Department:

- (i) Anjuman Girl's High School at 31, Mufidul Islam Lane, Kolkata 700 014
- (ii) Anjuman Islamia Girl's High School at 20, Noor Ali Lane, Kolkata 700 014
- (iii) Anjuman Girl's Primary School at 35, Mufidul Islam Lane, Kolkata 700 014
- (iv) Anjuman Mufidul Islam Girl's High School at 20, Noor Ali Lane, Kolkata 70014.
- (v) Anjuman Mufidul Islam Girl's Sishu Siksha Kendra at 20, Noor Ali Lane, Kolkata 70014.

The Anjuman has received help and co-operation from time to time from those concerned towards the progress and development of these schools which are landmarks for the Urdu Medium Education imparted to the girls of Kolkata. Anjuman Mufidul Islam Primary School was transformed to Anjuman Mufidul Islam Shishu Sikksha Kendra by the Directorate of Madrasah Education. Govt. Of West Bengal vide its Memo No. 320 dated 30-03-2011 With the personal initiative of Past Presidents and our President Mr. Amiruddin (Bobby) six (6) approved teachers were recruited in Anjuman Girl's High School and twelve (12) approved teachers were recruited in Anjuman Girl's Primary School.

Some of these Schools face shortage of funds owing to restriction in collection of school fees and decreasing number of students and hence the Anjuman extends its hand of support by allocating sufficient funds to these schools to tide over the financial crunch from time to time.

Schools assisted by Anjuman with funds during the year under report are as follows:

The School Building situated at 31, Mufidul Islam Lane, Kolkata – 700 014 was in a dilapidated condition and hence it needed to be demolished and a new structure erected. With this in mind the Anjuman prepared a plan and got it sanctioned from the KOLKATA MUNICIPAL CORPORATION. President Mr. Amiruddin announced that the structural cost of the new building would be borne by him and will be dedicated in the memory of his father Late Abdul Wahab. The demolishing of the building commenced from 14th September 2018.

Subsequently, with the co-operation of the Head Master Mr. Md. Ziauddin Nadeem, Anjuman was able to shift Anjuman Girl's Higher Secondary School to Islamia High School with convenient timings. The School was shifted to Islamia High School on $\mathbf{1}^{\text{st}}$ September 2018.

On 1st January 2019 the Foundation Laying Ceremony of Premises No. 31 Mufidul Islam Lane, Kolkata-700 014 of Anjuman Mufidul Islam, Calcutta was held. The Foundation stone was laid by Moulana Altafur Rahman and Honourable MP Mr. Sudip Bandopadhyay.

At the Foundation Laying Ceremony, Honourable MP Mr. Sudip Bandopadhyay committed that he would contribute Rs.50,00,000/- (Rupees fifty lacs) from his MP LAD Fund towards the construction of the building.

The Managing Committee of the Anjuman coordinates with the Managing Committee of schools to improve the quality of education being imparted which can be seen in the chart below:

Besides running six regular schools for girls, the process is on for an English Medium School at 16, Hati Bagan Road, Kolkata – 700 014 and a Montessori School and Madrasah at 31/3, Topsia Road South. Honourable MP Sri Sudip Bandopadhyay and Honourable MP Mr. Nadeem-ul-Haque have consented to donate towards these school from thier MP LAD Funds. The Anjuman is grateful to the Govt. Of West Bengal for extending a helping hand in promoting education with schemes like Mid Day Meals, School Uniform, Books and different scholarships like Kanyashree, Premetric and post metric scholarships through the Minority Department.

(b) Maktabs:

Several Maktabs are run by the Anjuman in different parts of Kolkata mainly in slum area for imparting education to the poor and needy children. Books and stationeries are provided to children free of cost at the Maktabs.




(b) MEDICAL SECTION:



The Homeo Charitable Dispensary at Narkeldanga Main Road also renders remarkable service in the treatment of poor patients. A qualified Doctor assisted by para medical staff manage this dispensary three days a week. During the year under report 3638 patients were treated in the dispensary. A new Homeo mobile Camp was started at Birjunala Badartalla from the month of September, 2013 which was later converted to a Homeo Charitable Dispensary is running successfully. The Motijhil Camp was closed due low response from the inhabitants of the locality.

5. TABLIGH SECTION:

A congregation of ladies from the Muslim Community assemble once a week for which the Anjuman provides space at 20, Noor Ali Lane, Kolkata-700 014 where religious instructions are imparted by qualified and knowledgable ladies. This section of Tabligh for women continued to work as ever before.

FINANCE

Zakat, Fitra, Qurbani Hide & Skin collections are the main sources of income of the Anjuman for which the Anjuman is grateful to the donors who contribute to the Anjuman generously which helps in providing relief to the poor and needy and the people in distress. The Anjuman is facing difficulties in maintaining its Kafan Dafan, Mobile Dispensary and General Funds. We solicit the co-operation and help of the people to contribute generously to these funds so that the Anjuman may be able to discharge its obligations smoothly and efficiently.

It is pleasant to note that the Anjuman enjoys exemption of Tax u/s 12A & 80G of the Income Tax Act,1961 which is helpful to the donors in making their contribution to the Anjuman Mufidul Islam, Calcutta.

PROPERTIES

The Anjuman owns and maintains the following properties in Kolkata:

A five storied building under construction at 31, Mufidul Islam Lane, Kolkata-14, which houses the Registered Office of the Anjuman, and the Anjuman Girls High & Higher Secondary School. which has been shifted temporarily to enable construction.

A four storied building at 35, Mufidul Islam Lane, Kolkata-14 which houses the Anjuman Girls Primary School. and the garage on the ground floor where the vehicles of the Anjuman are being kept.

A three storied building at 20, Noor Ali Lane, Kolkata which houses the Head Office of the Anjuman, the Anjuman Mufidul Islam Girls Primary, High and Higher Secondary Schools and the Anjuman Islamia Girls Primary, High and Higher Secondary Schools.

A two storied Building at 16, Hati Bagan Road, Kolkata – 700 014 which houses some tenants and the Anjuman Women's Tailoring Centre. The building is in a dilapidated condition and we are in the process of constructing a new building in due course. No objection certificates has been obtained from the Tenants

A property of the Anjuman Mufidul Islam, Calcutta at 7, North Range, Kolkata – 700 017 houses the Dini Maktab. The major portion of the property is still in the illegal possession of an encroacher. The Anjuman's case for recovery of possession of the encroached portion is still pending in the High Court of Calcutta,

A property of the Anjuman Mufidul Islam, Calcutta at 31/3, Topsia Road South, Kolkata – 700 046, which is being constructed with the purpose of opening a Montessori School and Madrasah.

- 1. Commencement of a proposed Montessori School & Madrasah at 31/3, Topsia Road, (South) Kolkata 700 046.
- 2. Construction of an English Medium School under the aegis of Anjuman Mufidul Islam, Calcutta at 16, Hati Bagan Road, Kolkata 700 014
- 3. Establishment of a proposed Technical School for girls at 7, North Range, Kolkata-700 017.
- 4. Completion of construction of premises no. 31, Mufidul Islam Lane, Kolkata 700 014 by June 2021
